## **INVITATION FOR BIDS – PHASE 02**

- 1. The Democratic Socialist Republic of Sri Lanka has received a loan from Japan International Cooperation Agency (JICA) towards the cost of the Rural Infrastructure Development Project in Emerging Regions (RIDEP).
